

PRIVACY POLICY

Bearry, LLC ("Bearry" or "www.bearry.com" or "we" or "us") has created this privacy policy (this "Privacy Policy") in order to demonstrate its commitment to user, visitor and customer privacy with regard to the Bearry web site at www.bearry.com (the "Website"). Privacy on the Website is of great importance to us. Because we gather important information from our users, visitors and customers (collectively "Customers" or "you" or "your"), we have established this Privacy Policy as a means to communicate our information gathering and dissemination practices. By accessing this Website, you acknowledge and agree to this Privacy Policy and also agree to the Terms of Use of the Website.

Information we collect and How we make use of it

We require Customers who register to use the services offered on our Website (collectively, the "Service") to give us personally identifiable information, which may include but is not limited to the Customer's first and last name, company name, address, phone number, email address, credit card number, cookies, IP logs, and other information (collectively "Personal Information"). Besides the Personal Information, we may also collect other information regarding your use of the Website, including general statistical or aggregate information, which may be collected whether or not you register for the Services offered on our Website. From time to time, we may also collect or ask for additional Personal Information, which will also be expressly included herein as Personal Information. You can opt out of providing this additional information by not entering it when asked or not using the Website, although not providing it may hinder your ability to use the Website.

We use the Personal Information and the information that we collect to provide and maintain the Website as we deem appropriate in our sole discretion. We may also use the information to contact you to further discuss interest in our company, the services that we provide, and to send information regarding our company or partners, such as promotions and events. You may be invited to receive an email newsletter or other correspondence by providing an email address. We may also email (or send via other methods) information regarding updates to the Website or Bearry, and may send a customer newsletter, or other correspondence. You will have an opportunity to unsubscribe to any emails or mailings by clicking on an "unsubscribe" hyperlink contained in promotional emails we send you, or by e-mailing us at our Customer Service Department. Any opt-out by you is not deemed valid until processed by Bearry. It is your obligation to verify that you have been opted-out. Bearry shall not be liable for problems with the opt-out procedures.

Except as we explicitly state at the time we request information, or as provided for herein or in the Bearry Terms of Use Agreement, we do not disclose to third parties the information provided. All financial and billing information that we collect through the Website is used solely to check the qualifications of prospective customers and to bill for the Service. This billing information is not used by Bearry for marketing or promotional purposes, except as provided for herein. We may use a third-party intermediary to manage the credit card processing and we may share any appropriate information with them.

In addition, we may share or disclose your information, including Personal Information, in the following situations:

- We reserve the right to disclose any Personal Information or other information if required to do so by law, including compliance with legal process served on Bearry, or if we believe that such action is necessary in order to (a) protect or defend the legal rights or property of Bearry, the Website or its Customers, or (b) in an emergency to protect the health and safety of the Website's users or the general public.
- Personal Information you submit, and other information we collect, may be shared with our parent, subsidiaries, affiliates, licensors, licensees, joint venturers, partners, sponsors and/or vendors (collectively, "Affiliated Third Parties") to perform customer service, carry out your requests, respond to inquiries, and to notify you regarding any promotions, purchases or account information.

- Personal Information you submit, and other information we collect, will be disclosed as part of any merger or acquisition, creation of a separate business to provide the Website or fulfill our services, sale or pledge of company assets as well as in the event of an insolvency, bankruptcy or receivership in which Customer information would be transferred as one of the business assets of the company.
- Personal Information you submit, and other information we collect, may be distributed or shared in order to conduct any business as we, in our sole subjective discretion, deem reasonable.

We do not respond to browser do-not-track signals or mechanisms.

You may be using the Website to host data (including but not limited to pictures, email correspondence with other users and other content) and information ("Data"). We will not review, share, distribute, print, or reference any such Data except as provided herein and in the Bearry Terms of Use, as may be required by law, or in order to conduct any business that we, in our sole subjective discretion, deem reasonable. Individual records may at times be viewed or accessed for the purpose of resolving a problem, support issue, suspected violation of any of the terms of this Website, as may be required by law, or as deemed necessary by Bearry. Of course, you are responsible for maintaining the confidentiality and security of your user registration and password.

Bearry may also collect certain information from visitors to, and users of, the Website, such as Internet addresses. This information is logged to help diagnose technical problems, and to administer our Website in order to constantly improve the quality of the Service. We may also track and analyze non-identifying and aggregate usage and volume statistical information from you and provide such information to third parties.

Bearry does not wish to collect any Personal Information (or any information at all) from any persons under 14 years old. If you are under 14 years old, you may not use the Website.

Anti-Spam Policy

Bearry.com subscribes to an Anti-Spam policy for all its communication protocols. This means that we do not condone unsolicited email messages, notifications, alerts or any message that you may receive from someone who should not have your email address.

Cookies

When you view our Websites, we may store some information on your computer's hard drive. This information will be in the form of a "Cookie." Cookies enable us to establish the shopping cart session and allow you to purchase products on-line at our site. Most web browsers automatically accept Cookies, but you can change your browser to prevent that. Without accepting a Cookie, you can browse through our site, but you will be unable to establish a shopping cart session and make a purchase on-line.
